2023-24 School Description and Mission Statement

The mission of North Hillsborough School is to collaborate with parents, staff, and the community to create a positive and caring environment where students feel safe and empowered to become active learners, grow from mistakes, develop their creativity, and reach their potential as global citizens of an ever-changing world.

The school has 13 regular classroom teachers. All of the regular classroom teachers are fully certified. There are two Learning Center classes. In addition, North also has a full-time librarian, music teacher, PE teacher, Innovation Lab teacher, one full-time Resource Specialist, one full-time counselor, a full-time Reading Specialist, and a full-time speech therapist. The school shares an instrumental music teacher with the two other schools. An occupational therapist and school psychologist are shared with one of the other elementary schools.

The curriculum at North is aligned with the Common Core State Standards. In literacy, the school uses Open Court and Wonders for reading and in 4th and 5th grades, teachers use Units of Study for Teaching Writing by Lucy Calkins for writing. This curriculum stems from the principles of Balanced Literacy: shared reading, guided reading, independent reading, shared writing, independent writing, guided writing, phonics, and word work. For math, Math Expressions is in its third year of implementation. In addition, teachers use SVMI and SFUSD math initiatives. We are currently using TWIG Science as our school's science curriculum and using Scott Forseman for social studies.

Parent participation is an integral part of the North school community; parents participate in and outside the classroom by leading committees, organizing school events, and volunteering hours in the library, in the school cafeteria, Service Learning, Art in Action, traffic drop off and during classroom instruction. The school's Parent Executive Board oversees most of this process and collaborates with the principal throughout the year to develop a deep partnership between parents and staff.

Units of Study in Writing (Heinemann) in 4-5 is used as supplemental curriculum for Reading/Language Arts. Quaver is used in K-5 vocal music. California Studies Weekly was purchased for all K-5 teachers to support history-social studies instruction for the 2023-2024 school year while a team engages in the instructional materials adoption process. Mystery Science is used as a supplemental science curriculum over the 2023-2024 school year during implementation of HCSD's recently adopted NGSS-aligned science curriculum. Educators also use various online district-provided resources to supplement instruction, as appropriate to content area and age. Such resources include, but are not limited to: Freckle, FactCite, Renzulli Learning, Lexia Core 5, Raz-Kids, and more.

School Facility Conditions and Planned Improvements

The Hillsborough City School District inspects all of its facilities, both buildings and grounds, yearly to determine if any major repairs are needed. The District uses a facility inspection tool developed by the State of California's Office of Public School Instruction. Inspection by Buildings and Grounds personnel of the eight emergency facility needs specified in Ed. Code 17592.72c was last completed October 2022. The results of this facility survey are available at the District Office.

In addition, the school district maintains a work order process to ensure efficient service and that emergency repairs are given the highest priority. Work orders can be prepared by a staff member, or suggested by a parent. Work orders are prioritized district-wide by the Supervisor of Buildings and Grounds. The district maintenance staff ensures that repairs necessary to keep the schools in good working order are completed in a timely manner.

Currently, all of our schools employ a full-time day custodian and a full-time night cleaning service. All classrooms, staff rooms and all student and staff restrooms are cleaned, and sanitized nightly. Cleaning schedules and duties are monitored regularly by the sites and the maintenance department to ensure safe and clean schools.

In the 2021/2022 school year, the District applied for grant funding with the CalShape Ventilation program, AB 841. The CalShape Ventilation program provides funding for HVAC assessment, general maintenance and adjustment, filter upgrade replacement, carbon monoxide monitor installation including certain repairs, replacements and other improvements to HVAC systems. The District has completed all that is required for all campuses to be reimbursed.

In June 2022, voters passed the Measure H bond. During Summer 2023, the following projects were completed at North Hillsborough School: painting of the exterior of the school and technology upgrades including the installation of new SmartBoards. During the 2023/2024 school year, new classroom furniture is being piloted in some classrooms with an anticipated purchase for all classrooms during the school year. The installation of a solar/electric announcement board, a new roof, and new HVAC will occur in 2024.

2023-24 Opportunities for Parental Involvement

Opportunities for parental involvement in the district and at the school site are abundant. Our parents have always generously given their time, attention, and money. Their efforts mean far more than the material benefits they bring; they make our students and teachers feel valued and important. Such feelings contribute directly to our educational excellence.

In the 2022-2023 school year, parents and other community volunteers contributed thousands of hours directly to North School in the classrooms, and in the library, helping with hot lunch, serving on committees, and assisting with special projects. Parent volunteers shelve, check out, and check in library books and serve as classroom volunteers. Chaperones and docents help organize and run many school events such as the STEAM EXPO, Service Learning Programs, Art in Action and Book Fair. In addition, parents and community members speak to classes, read stories to young children, and share their occupational or scientific expertise. Through organizations such as the Parent Group and the School Site Council, parents learn about activities at the school and set goals to raise student achievement and continually improve the school.

At the district level, thousands of additional volunteer hours are given to fund-raising events, sponsored by the Hillsborough Schools Foundation. These events include Giving Day, the Hillsborough Classic, Spring Online Auction, Dinner Dance & Live Auction, and the HSF Fun Run. The Hillsborough Schools Foundation provides funds annually to the district in order to enhance the already excellent educational programs. These contributions allow us to enrich our students' educational lives and to be able to continually look for ways to be even better. Parents and community members have also continuously supported the schools through their votes: In June of 1988 and again in 1992, the community passed parcel tax measures in order to maintain school quality. In November 2002, the community of Hillsborough passed Measure B, a \$66.8 million dollar school bond measure for the purpose of modernizing, renovating, and adding facilities as needed at our four school sites. Just under 20 years later, in June 2022, community members approved the Measure H bond to support further modernization and renovation of its school facilities. Voters approved the \$140 million bond measure by 61.44%. All members of the school community worked hard to inform the voters about the need for the measure. This much-needed bond will help keep our schools in top-notch shape, able to respond to the changing needs of our learners and our community.

Parents are kept well informed about the school through the school newsletters, calendars, web pages, parent group meetings, parent education events, and parent conferences. Any parent wishing to contribute time, expertise, or money to the schools

2023-24 School Safety Plan

Safety is our number one priority in the Hillsborough City School District school community. We focus on maintaining safe and caring school communities where all students and families feel welcome, valued, and respected. When students feel safe at school they can focus on learning.

The Comprehensive School Safety Plan, developed in conjunction with the San Mateo County Office of Education and City Services, includes disaster preparedness and emergency procedures, and provides the basic guidelines for responsibilities and procedures needed to address major emergency situations. This plan is updated and reviewed with staff annually.

HCSD has a District Safety Committee that meets a minimum of 5 times a year for planning and trainings. The committee is comprised of five teachers, three classified staff members, and two district administrators. The committee is responsible for keeping the Incident Command System organizational chart current, attend disaster preparedness trainings, and be the liaison between the District Safety Committee and Site Safety Committee. At the site level, the Safety Committee is responsible for maintaining emergency backpacks for each classroom, inventorying the emergency shed, and reviewing Big Five Protocols

With additional funds supplied through the generosity of our parents and the larger community, we are also able to provide lower class sizes, curriculum specialists, instructional coaches, additional counseling and intervention services, and other enhancements to programs. Resources are allocated based on the assessed learning needs of students.

Professional Development

District Overview:

Each year the district offers training to its new teachers before the start of school and continues with specific new teacher support for the first year, Participants in the BTSA (Beginning Teachers Support and Assessment) program receive support for two years through HCSD and the SMCOE. Generally, the district provides three full days of professional development for teachers each year and supports the continual professional growth of teachers through grade-level and department-specific professional development throughout the year. One additional professional development day is reserved for teachers to work in their classrooms and a second professional development day occurs on the first day that staff returns each year. This day is designated for staff and district meetings, association meetings, and professional development. Teachers participate in off-site professional development opportunities on a regular basis, and expert consultants are contracted to support professional learning in HCSD. The district encourages veteran teachers to continue professional growth through its HIP (Hillsborough Incentive Plan) Program and by providing support for teachers who wish to become Nationally Board Certified or recieve other continuing certifications. Compliance training for certificated and classified staff, such as CPR/First Aid and CPI training, is held as needed. Specialists are provided training relevant to their assignments and training occurs any time new standards or materials are adopted. Instructional minutes are added throughout the week to allow for early release Thursdays. Thursday afternoons are available for both school site and district staff development or collaborative workgroups. This is in addition to the weekly teacher, grade-level, and/or departmental collaborative time provided in the schedule. The administration and staff maintain a mutual support system with close communication and strong cooperative planning. Beginning in the 2021-2022 school year. Instructional Coaches have been utilized to support individual teacher curriculum and instruction support and to provide a resource for district initiative and curriculum implementation.

District Specific:

During the 2021-2022 school year, the HCSD provided professional development on supporting gifted students, a Multi-Tiered System of Support, Universal Design for Learning, mental health, and understanding gender identity. Additional professional development focused on particular curricular areas, teaching practices, and diversity, equity, and inclusion-related learning will be provided based on identified needs. Professional development around COVID-19 safety procedures was also provided as needed.

During the 2022-2023 school year, the HCSD continued on the trajectory set in the previous year by providing professional development on Universal Design for Learning as a main focus area. Support for gifted students, understanding the connections to HCSD's Multi-tiered System of Support, supporting student and educator mental health, and focusing on inclusive classrooms and schools is ongoing work addressed through means described above.

During the 2023-2024 school year, the HCSD continued to provide professional development linked to Universal Design for Learning (UDL), recent curriculum adoptions, and instructional practices. Professional development identified by specific departments to support educator growth and student learning will continue to be provided throughout the year.

North School Specific:

At North School, we hold professional development as a priority and have strategies in place for communication and collaboration between and among colleagues to ensure success for all students. Collaborative times are provided within the week's schedules to allow opportunities to examine student work and assessment data to formulate differentiation strategies and coordinate curriculum. These collaborative opportunities are afforded as students work with specialists in music, physical education, and library science. Professional development in foundational skills and Multi-Tiered Systems of Support will occur throughout the year. Thursday afternoons are relegated to cross-grade, multiple-grade, and vertical planning groupings wherein we will articulate best practices, share research-based strategies, and plan to build alignment of our K-5 writing practices. In the 2022-2023 school year, North teachers have had access to expert coaches and interventionists to fine-tune practice and provide more differentiated opportunities for students. In addition, Site Principal, RSP teacher and CARE Team members attended Executive Functioning professional development. Site Principal attended professional development around chronic absenteeism. ILab teacher attended summer PD at Nueva and fall 2023 PD at CUE conference.
