

### <u>Implementation Planning</u>

The Measure H Facilities and Construction Committee continued its work on the bond program's implementation plan. The Committee has already had over ten touchpoints with the public, staff, and interested parties to gather input and recommendations on the Implementation Plan. They have also presented to the Board of Trustees multiple times.

The Implementation plan will include a Bond Program Schedule, a Bond Program Budget, and a final project list for Measure H. These documents will serve as a road map for the bond program. It will also be a living document that will be revised approximately once a year to adjust budgets as needed, the project list, and/or the bond schedule to allow the Board of Trustees the opportunity to adjust projects as required to meet the ever-changing needs of the district.

The Facilities and Construction Committee is finalizing its presentation to the Board of Trustees, which will take place in March.



# Citizens Bond Oversight Committee Members Needed

In November 2000, the voters of the State of California approved an amendment of the California Constitution (Proposition 39) lowering the voter approval requirement from 2/3rds to 55% for school districts that provide voters a specific list of projects, a committee of appointed citizens to oversee the expenditure of funds and an annual performance audit and financial audit of the bond funds and bond projects. In addition, Proposition 39 provides that the Citizens' Bond Oversight Committee shall have at least seven (7) members who shall serve up to two (2) terms of two (2) years each.

Measure H was passed in compliance with Proposition 39, and the Hillsborough City School District is establishing a Citizens Bond Oversight Committee for this bond measure. If you are interested in serving on the committee, there are open seats; please get in touch with the district office for an application.

#### Quick Start Projects

The Board of Trustees authorized the Facilities and Construction team to begin work on the following projects:

- Painting and Waterproofing of South Elementary School
- District-wide marquee sign installation
- Remodel of South Elementary School Building A
- District-wide Classroom Technology Upgrade
- Solar Viability Study

Design professionals for the painting of South Elementary School have been solicited and selected by the district. Color options are being prepared for the site and District staff to review and choose. At the same time, at South, the Facilities and Construction Committee is reviewing flooring options to establish a standard for the district and kick off the Building A remodel.

Our two technology upgrade projects are the classroom technology upgrade and the marquee signs. Both kicked off in the month of January and are moving forward. Meetings have been held with the Technology Committee to assist in finalizing the classroom technology equipment selections.

The District is considering adding solar structures district-wide. The Facilities and Construction team is actively working with energy consultants to determine constructability, the size of the system, and the locations of panels to determine if solar is an option for the district.
